The Project includes the following Work: This project will include the relocation of the current sanitary sewer forcemain piping located in the Richmond Dam. Work shall include the installation of approximately 1,836 linear feet of 4" forcemain directionally bored under the lake bed, 174 linear feet of 4" forcemain direct bury, air release manhole, connection to the existing forcemain piping, and other required appurtenances to complete the work.
